



SMBC Singapore Open Discover Golf Carnival

General Terms and Conditions

1. The Discover Golf Carnival (the “**Carnival**”) is to be hosted by the Singapore Golf Association (“**SGA**”), and the promoter of the Tournament, Lagardere Sports Asia Pte. Ltd (the “**Promoter**”) (together, the “**Organisers**”) on Sunday, 13 January 2019 at Sentosa Golf Club, in the lead up to the 2019 SMBC Singapore Open (the “**Tournament**”).
2. By completing and submitting this online registration form and attending the Carnival, you are representing to the Organisers that you have read and understood these General Terms and Conditions with respect to you and your group’s attendance at the Carnival and agree to comply with all instructions and guidelines set forth by the SGA and/or the Promoter.

GENERAL

3. If the SGA and the Promoter receive more registrations than available capacity for the Carnival, they reserve the right to select attendees at their absolute discretion, which may include prioritising participants who have lesser experience. Attendees may be requested to vacate the venue following their designated session in the event that the subsequent session is full to capacity.
4. General registration for the Carnival via this form does not include entry into the Skills Challenge. Participants wishing to participate in the Skills Challenge must register separately using the applicable form, acceptance of which shall be subject to confirmation by the SGA or the Promoter.
5. Either the SGA or the Promoter may postpone, cancel, interrupt or stop the Carnival (which may include in the event of haze / lightning / other unforeseen circumstances) and will endeavour to give advance notice of the same via the Tournament’s social media channels. It is the responsibility of attendees to check the social media channels for updates prior to attending.
6. Participants attending the Carnival must follow instructions of the SGA and the Promoter at all times and all children must be accompanied by a parent or guardian when on-site at the venue.
7. Drinks, catering and/or goodie bags may be provided at the Carnival at the discretion of the SGA and the Promoter. If made available, the selection of food and drinks shall be at the discretion of the SGA and the Promoter.
8. Participants are required to be in appropriate attire for the activities taking place at the Carnival.
9. Neither the SGA nor the Promoter will be responsible for any costs associated with the attendance and participation of the Carnival, including without limitation to transport fees, parking fees and admission fees into the designated venue(s) which shall be the sole responsibility of the participants.
10. You shall be responsible for the cost of rectification any damage caused by you or your child when attending the Carnival (fair wear and tear excepted).
11. Information provided by you in this form shall be used in accordance with all applicable data protection legislation.



PARENT/GUARDIAN DECLARATION

12. If registering for a child to attend the Carnival, you are deemed to represent and warrant to the Organisers the following:
- You are the parent or guardian of the child and hereby consent to the child taking part in the Carnival.
 - You shall, and shall procure that the child shall, obey any instructions relating to the Carnival, including but not limited to health and safety instructions, given by the Organisers and the venue.
 - You warrant and represent that the child's general health is good and there is nothing which renders him/her unfit to undertake the abovementioned Carnival.
 - You are aware and understand there may well be risks, hazards and dangers involved to which you or the child would be subjected during his/her participation in the Carnival, including but not limited to exposure to the sun, injury and insect bites.
 - You hereby voluntarily assume the risks inherent in your attendance at and you and/or the child's taking part in such an activity and exclude, to the fullest extent permitted by law, the Organisers and the venue (and their respective officers, employees, agents, contractors and representatives) from all liability for any loss, damage, injuries or death that may however be caused to you or your child whilst in attendance at the Carnival.

USE OF IMAGES

13. You hereby consent and agree to the following:
- The photographing, filming and/or sound recording of you or your child during participation in the Carnival by the Organisers, including their respective appointed photographers and/or videographers.
 - The Organisers shall be permitted to use, reproduce, broadcast, distribute, publish and republish the photographs, video recordings and/or sound recordings of you or your child **PROVIDED ALWAYS** that such permitted use shall only be limited to the following:
 - non-commercial uses, including corporate videos and presentations relating to the Carnival and the Tournament; and/or
 - news and/or editorial coverage of the Carnival and/or the Tournament on various media platforms. For the avoidance of doubt, news or editorial coverage envisaged herein shall include permitting media operators, broadcasters and/or publishers reproducing, broadcasting and/or publishing the photographs, video recordings and/or sound recordings for news or editorial coverage of the Carnival and/or the Tournament.
14. Any other use of photographs, video recordings and/or sound recordings of you or your child which is not described in the abovementioned must be subject always to your prior approval and consent.
15. You hereby agree and acknowledge that the essential information provided in the online form and the photographs, video recordings and/or sound recordings taken of your child in accordance with Paragraph 13 will be retained by the Organisers for as long as necessary to fulfil the purposes set out herein and to the fullest extent permitted by law.
16. The SGA and the Promoter's decision in respect of all matters in relation to Carnival will be final, conclusive and binding. No correspondence, appeal or complaints will be entertained.
